

## **GENERAL BETTING REGULATIONS BETONALFA ( Betonalfa Ltd – A 005)**

### **REGULATIONS APPLY FROM 01/01/2023**

#### **Explanation of terms**

"Company" - The company licensed by the Betonalfa National Betting Authority LTD .

"Performance" - Refers to the price offered by the "Company" for a particular "Bet". The "Return" represents the amount paid by the "Company" for each winning "Bet" worth one betting unit.

"Coupon" - Description of offered "Bets" offered by the "Company" and published in printed or electronic form for betting and public information purposes.

"Bet slip" -. Registered "Bet" printed by a terminal machine of the "Company" which describes the "Bet" and which the "Client" receives as proof. Each "Deed" is the sole contract between the "Company" and the "Customer" evidencing its existence and ownership on behalf of the "Customer". The "Bet Slip" includes information about the agency of the "Company" where it is registered, the date and time of registration, a unique identification code, the events chosen by the "Client", their times, their "Odds", "Bet" type description, barcode ( bar code ) and other details.

"Bet" - A valid bet validated by a terminal machine of the "Company", registered in the central computerized system of the "Company" and a "Bet Slip" printed for it.

"Client" - Person who has participated in the bets accepted by the "Company" and for whom at least one validated "Bulletin" has been issued.

"Regulations" - This text which describes the general conditions governing the conduct of "Betting" between the "Company" and its "Customers", as well as additional conditions written on the "Bullets", on "Coupons" and notices posted in the "Company's" "Betting" agencies or announced through press or electronic media such as teletext or websites.

"Agent" - an authorized person or company or premises licensed by the National Betting Authority, who conducts "Betting" on behalf of the "Company" after approval by the "Company".

"Win Calculation Date" - The time when, during the process carried out by the central computerized system, a "Bet" is determined and recorded as won.

"personal data" - personal data and details of natural persons which the company collects, manages and maintains in the context of providing its services and protects the processing thereof in accordance with the personal data protection policy as set out in the Company's Privacy Policy.

#### **GENERALLY**

##### **1.1. COMMENCEMENT OF REGULATIONS**

The following "Regulations" are valid from 01/01/2023 and govern all "Bets" accepted by the "Company". However, in the event of a dispute, the "Company" will attempt to resolve the "Customers" complaints directly with the "Customers". "Customers" of the "Company" must read, accept and follow the following "Regulations". Possession of a "Betting Slip" issued by the "Company" implies what is stated in the receipt itself, that the "Customer" acknowledges and accepts the "Regulations" listed and which can be consulted at the Betting Agency "Representative " or in any other official place of the "Company".

## **1.2. WORKING HOURS**

The normal activities of the Betting Agency, ("Agent") can only take place during the specified working hours according to the "Company" (09:00-24:00). The "Company" reserves the right to cancel at will any "Bet" placed outside of its head office business hours, even if the "Bet" has been accepted by the computer and the relevant receipt has been printed. The working hours of the "Company" are announced on its official sites. Opening hours may be extended during certain events.

## **1.3. BET ACCEPTANCE**

" Bets " are only accepted by adult customers (18 years and over).

## **1.4. VALIDITY OF ACCEPTANCE OF BET**

No "Bet" is accepted until the "Customer" has in his hands a valid receipt, "Bet Slip", subject to the "Regulations" of the "Company". The "Company" reserves the right to refuse acceptance of all or part of any "Bet" at the time it is offered. "Bets" placed through the "Company's" terminals are only accepted if they have been submitted to the "Company's" generally approved "Betting" procedure. No other format is permitted unless specifically approved by the "Company". Only 'Bets' which end up in the computer records of the Betting Agency and by extension the computer records of the 'Company' will be validated and accepted. The "Client" is obliged to check that the printout of the "Bet" from the computer corresponds to the requested "Bet". If he does not respond, the "Customer" must request the cancellation of this "Bet" within 10 minutes.

## **1.5. CANCELLATION OF BET**

The "Client" can request the cancellation of his "Bet" within 10 minutes of its printing. However, if a game included in the 'Bet' has started before this time has elapsed or has options whose 'Odds' have been varied, then the 'Bets' cannot be canceled without the approval of "Company". Cancellation of bets cannot be made for bets concerning "LIVEBETTING". Cancellations of 'bets', which do not include invalid matches or price options which have been changed, can only be requested in the following cases:

- If there is an error on the computer of the Betting Agency, "Agent" and the "Bet" was not recorded.
- If the computer does not print a receipt.
- If a mistake has been made in entering the 'Bet' options or the 'Bet' amount.

If more than 10 minutes have passed since the Bet was accepted, the cancellation request must be received by Company staff, via email or fax, before the start of the first event in the Bet. The "Company" has every right to refuse to cancel any bet.

## **1.6. BET ACCEPTANCE TIME**

The "Company" reserves the right to declare as void any "Bet" / selection that ends up in its network, transmitted by the Betting Agency / ("Agent"), after the start of the sporting event, to which the "Bet" refers / option, with the exception of live "Bets" ("Bets" during the game). Predictions for matches that do not take place or are postponed for any reason will remain valid for 48 hours. If after 48 hours the match has not been played, it will be considered void (VOID) in the 'Bet Slip'. The above forecasts for the purpose of calculating profits are considered with a "Performance" of 1.00 (unit). If the start date and time entered into the "Company's" computer is after (by mistake or for any other reason) the actual date and time of the event and the event is either in progress or has ended, all options for the event will be subject to cancellation and 'Bets' will be refunded, with the exception of live 'Bets' ('Bets' during the game). Where a "Bet" consists of several options, and one or more of the events to which it refers is already in progress or has ended at the time the "Bet" is received by the "Company's" network, the option(s) are calculated with a percentage of 1.00. The remaining options are valid and will be recognized.

### **Example 1**

"Bet" (PRE-MATCH) €20 Total of 5 teams since the selections are three (3) as a minimum accepted.

LEEDS

LUTON

YORK

MILAN

ROME

If LEEDS and LUTON have already started at the time the 'Bet' is accepted by the 'Company', the 'Bet' will be treated as a 3 team 'Bet', worth €20, with LEEDS and LUTON valued at 1.00 .

## **1.7. VALIDITY OF BET**

Each validated 'Bet' by the 'Company' will be entered in the general file and in a second file for security purposes, called the 'security file'. The "Odds" that apply at the time the "Bet" is recorded are the "Odds" based on which the potential winnings will be calculated. When calculating profits, only the content of the receipt through the records of the head offices of the "Company" is valid. In the event that the customer's receipts show different information from those stored in the head office files, the "Company" reserves the right to consider only the information included in its security files as valid. It is noted that, in case the above occurs, the company is called upon to adequately justify the correct information.

## **1.8. BET ACCEPTANCE DETAILS – CHANGES IN ODDS**

The minimum number of selections that can be selected on an event ("Bets"), allowed per combination and any other limiting elements, are indicated by the computer. It is the responsibility of the person in charge of the Betting Agency, "Representative" to confirm these claims.

The "Company" reserves the right to change any "Odds". The actual "Output" for any selection always remains the "Output" printed at the time of validation on the "Bet Slip". For this reason "Customers" are urged to check their "Bet Slips" with particular care.

### **1.9. APPROVAL OF BETTING**

If the Betting Agency, "Agent" receives "Bet" requests that exceed the specified betting limits set by the "Company", it will be necessary for the person in charge to request a special authorization for the approval and acceptance of such "Bet", the approval of which subject to the discretion of the company. Set betting limits vary by league, match, market/bet type. In any case, the specified betting limit is displayed in the system when the bet is placed.

### **1.10. LINKED BETTING**

Related contingencies (options with logical connections) such as LIVERPOOL to win 2-0 and LIVERPOOL to lead in the first and second half are accepted in singles only (after being offered for betting by the "Company", and where wrong totals are received "Bets", the 'Bet' will be divided equally for each quoted probability. An exception to this rule is 'Bets' where a special combined 'Odd' is quoted.

### **1.11 . PAYMENT OF PROFITS**

Payment of winnings will only be settled upon presentation of the original receipt of the "Bet Slip" which includes the authenticity code and which authorizes payment from the computer of the Betting Agency ("Agent"). In case of payment of profits in any way other than the above the "Company" bears no responsibility. Any differences will be announced by the "Company".

Any winning 'Bet' can be redeemed up to two (2) months after the 'Winning Calculation Date'. Any "Bet" not redeemed during the above two months will be considered by the "Company" as expired and worthless, except in certain special cases.

In case of loss, total or partial destruction or in general in any case where it is not possible to locate and recover a winning "Bet", the claim for payment of profit and any other claim for compensation from the "Company" is excluded.

If the outcome of an event cannot be officially verified, the "Company" has the right to delay any payment until official verification, in which case the player will have the right to redeem a winning ticket up to two months from the date of verification. In case of incorrect calculation of profits, the "Company" reserves the right to correct before and after the payment of profits.

The company has the obligation to implement due diligence measures for every player who carries out a transaction equal to or more than €2,000. When such a case arises, the player's anonymity is removed and the company is obliged to collect the following information about the player:

- player name
- date and place of birth
- nationality

- address of permanent residence
- contact details (phone and/or email)

### **1.12. MAXIMUM LIMIT OF PAYMENTS**

Each "Bet" is subject to a maximum win determined by the "Company" in the "Maximum payout limits" paragraph as below. The maximum win in the event of a multiple bet may be less than the maximum limit of a specific market, in the event that the total profit exceeds the maximum payout limit of another market included in the same bet slip. .. The maximum profit may be less than the computer calculation. In this case, the amount of the maximum payment limit is indicated on the receipt of the bet slip as the amount of return of winnings".

In such cases the limits stated in the "Regulations" always apply.. If a "Bet" includes option(s) referred to in different types of "Bet", then the minimum maximum payout limit applies to the entire "Bet" .

#### **The maximum payment limits per customer per day are set as follows:**

- Final results (1 X 2) for all football matches except Cyprus = €100,000
- " Bets " on one (1) or more Cypriot matches in any type of " Bet " = €20,000
- Football Specialties (it's all " Bets " and special coupons, except final results) = €50,000
- Live Football " Betting " (Live Betting) = €50,000
- Pregame , Live Betting and Ante - Post " Betting " on Basketball, Tennis, Football, Formula 1 and any other sport = €20,000
- Special " Bets " such as Football Ante Post and Eurovision the Company sets a maximum payment limit of € 30,000. With the exception of political bets (eg Presidential or Parliamentary elections) where the maximum payment limit is €10,000

#### **Example**

A "Bet" with football selections of which 1 selection is a Cypriot match is necessarily settled at the maximum limit of the Cypriot matches (if the maximum payout limit for the Cypriot matches is lower). B.C. Chelsea , Liverpool , Bayern , Apoel (Maximum payment limit €20000)

All maximum payout limits set out in these rules apply to any 'Customer', or group of customers betting together, and betting on the same or similarly themed combination of pick/s, even if this is done in a series of ' Betting', at a range of prices, within a few days, using different Betting Agencies, "Agents". If the "Company" has reason to believe and determines that a number of "Bets" have been placed in this manner, the final payout of those "Bets" combined, will be limited to a single maximum payout as stated above.

### **1.13. TYPOGRAPHICAL ERRORS**

In the event of misprints, errors in receipts or obvious errors in data entered into the Company's computer, the Company reserves the right to cancel such "Bets", or to settle such "Bets" at the correct

rates, " Odds', even if the discovery of the mistake is made after the event has been completed. The canceled "Bet" is refunded if requested by the "Customer". The "Company" bears no responsibility for the validity of the information it provides to its "Clients" regarding the dates and start times of the matches, scores or any other information that may be considered important by the "Clients". Mistakes made by the "Customer", the staff of the "Company" or its stores are not recognized and all "Bets" will be checked for any winnings based on the "Regulations". Any obvious typographical error contained in the "Coupons" and other forms issued by the "Company" does not bind it. In particular, any obvious typographical error in listing the prices, "Performances" paid by the "Company" regardless of any result or combination of results in the "Coupons", does not bind the "Company". As an obvious typographical error will be considered any "Performance" that is at least 30% higher or lower than the average prices for the specific "Bet" or combination of "Bets" given by Cyprus betting companies (those that hold a legal license to conduct " Betting" from the Republic of Cyprus). If the "Odds" of the matches shown on the "Company's" teletext service or live results service differ from the "Odds" shown on the "Bet" receipt issued by the agency's computer, "Agent", then always correct "Odds" are considered those indicated on the bet receipt issued by the computer of the agency, "Agent", and the "Odds" at the given time in the teletext service do not bind the "Company". Also, results of events which are listed in the teletext service, serve informational purposes and do not bind the "Company".

#### **1.14. CLAIMS AND ANOMALIES**

Where there is evidence of irregularities in a match or any other event, the "Company" reserves the right to cancel or defer payment of the contested selection, pending the completion of an investigation by the official governing body of any relevant sport, you understand that the Company will provides sufficient documentation to the customer for the above reasons The "Company" will seek criminal sanctions against any "Customer" involved in fraud, dishonesty or criminal acts. The "Company" will withhold payment to any "Customer" when there is suspicion or evidence of any of the above. The "Client" shall indemnify and shall be legally liable to pay to the "Company", on demand, all costs, charges or damages incurred or incurred by the "Company" (including any direct, indirect or consequential damages , loss of profit and reputation) and which derive directly or indirectly from the fraud, dishonesty or criminal act of the "customer".

#### **1.15. COMPLAINTS – BETTING DISPUTES**

For any problem, formulate your complaints with the necessary details, and send them to the headquarters of the "Company", within 15 days from the completion of the event to which your complaint refers. For any complaints or requests regarding "Bets", "Customers" must address the representative of the "Company" where the relevant "Bet" is registered. In the event that the specific complaint or request cannot be resolved by mutual consent, then each interested party may submit their complaint to the National Betting Authority pursuant to Directive 20/2017, at the email address [complaints @ nba . gov . cy](mailto:complaints@nba.gov.cy) .

#### **1.16. SUPPLEMENTARY REGULATIONS – APPENDICES AND ANNOUNCEMENTS**

General Appendices and Notices issued by the "Company" from time to time form part of these "Regulations". The "Company" reserves the right to modify the "Regulations" with a relevant announcement (the change of the regulations will be made assuming that they have been approved by the National Betting Authority) . Any previous "Regulation" of the "Company" shall be considered void, as long as a new "Regulation" has been issued by the "Company" regarding said "Regulation".

### **1.17. INTERRUPTED AND POSTPONED MATCHES**

The result at the end of the event will be considered the final result. All football "Bets" will be calculated based on the normal duration of a match (including stoppage time). Any extra time or penalty shootout or Golden Goal shootout **do not count**. In the event of a final interruption before the end of the event, options that have already been judged (in whole or in part) are considered valid. Selections deemed to have been decided in their entirety are selections which are already lost or won based on the result at the time the match was stopped and there was no possibility of changing their result if the match continued. Eg, in football if the hypothetical match MILAN-JUVENTUS is stopped at 60' minute and the result is 0-0, then all "Bets" that have not been decided are void (VOID), but wins e.g. the HALFTIMEBET option which has already been decided (score X) and any other option which has already been decided. In this case those who bet on the result of half X win and those who bet on the result of half 1 or 2 lose because if the match continued then the result of their 'Bet' would not change. Those who bet on the CORRECTSCORE 0-0 prediction get their "Bet" money back, because if the match had continued, then the result could have changed.

In the event that an event/match is interrupted during its duration and continues within 48 hours of its start from the minute of its interruption, then all open "Bets" concerning the specific event/match will be settled based on the final result. In the opposite case, i.e. where an event does not continue from the point of its interruption but starts from the beginning, then all "Bets" will be settled as **void with a "Performance"** of 1.00 (unit).

Predictions for matches that do not take place or are postponed or interrupted for any reason will remain valid for 48 hours from their scheduled start time. If after 48 hours the match is not played, they will be considered void (VOID) in the "Bet Slip" and for the purpose of calculating winnings they will be considered (void) with an "Odd" of 1.00 (unit)

### **1.18 MATCHES NOT PLAYED AS LISTED AND NEUTRAL FIELD**

Announcements for matches played at a neutral ground are for informational purposes only. The "Company" will always try to inform/inform about any change of venue or about any match being held on a neutral ground. The "Company" will not be held responsible in the event that it fails to announce/inform about a match held at a neutral ground.

### **1.19. RESPONSIBILITY OF CUSTOMERS**

The "Customer" by submitting the "Bet Slip" irrevocably declares that he has read, understood and fully accepted the "Regulations" of the "Company" as posted on our official sites and acknowledges that the acceptance of the "Bet Slip" is subject to control and verifying his agreement with the "regulations" and announcements of the "Company".

All "Customers" are obliged to check their "Bet Slips" that they have been filled out clearly according to their predictions and instructions. For this reason, the responsibility for the correctness of the proof rests with the "Customer".

No errors of the "Customer", head office staff or "Agents" of the "Company" are recognized and the control of all "Bets" for any winnings will be based on the "Regulations" of the "Company".

### **1.21. TECHNICAL PROBLEMS**

The "Company" bears no responsibility in the event that due to technical problems it became impossible to validate a "Bet".

## **SPECIAL RULES-GENERAL CLARIFICATIONS**

### **2.1 DEAD – HEAT REGULATION**

In the event of an event ending in equal amounts with more than one winner, where only one winner has been considered, the DEADHEAT rule will apply. A dead-heat result is a result in which two or more contestants share a final place.

In the event that two contestants share the final position, the selection is considered half won and half lost, and is therefore settled at full percentages ("Odds") and half the stake amount. Example:

If 3 players share the top scorer position in the world cup, then the bet amount is divided accordingly (1/3 of the bet amount X the odds).

### **2.2 DIFFERENT RESULTS**

I. The results are those that are recognized inside the playing field or on the podium of the winners. Any results due to legal, disciplinary or other decisions that alter the results or order of finish will not be taken into account. If the investigation of the competent body is done on the same day of the event, then its result will be used and valid, but if it is done the next day or at any other time in the future and reverses the result of the event, it will not be taken into account. B.C. if Vettel wins the Grand Monaco Prix and the following day voided by the FIA for some offence, all Bets involving Vettel to win the Grand Prix Monaco Prix will stand and be settled as won.

**ANTE POST : II** . With reference to Championships, which were not completed on the basis of their announcement and in which the relevant Federation or the competent Organizing Authority decides to validate the score as final, the settlement of betting options as won or lost will be based on this decision of the competent body .

III . In the case of leagues where playoffs are held, the final classification of the leaderboard will only be valid after the playoff games have been completed in the respective league, unless the condition of paragraph 2.2 II arises, in which case the provisions stated there apply.

### **2.3. THE PLACEBET (bet on a team to place)**

The "Customer" chooses the "Bet" place if he wants to back a Team/Athlete/Driver to finish in a predetermined position. The profit depends on the betting experts for the specific event.

If the proposition '1/4 'ODDSINPLACES 1,2' is written under the "Odds" to win a championship, the "Customer" wins 1/4 of the profit offered to win if the team he bet on finishes in two (2 ) first places, or if the proposition '1/3 'ODDSINPLACES 1,2' is written under the "Odds" of winning a championship, the



"Customer" wins 1/3 of the profit offered for winning if the team he bet on finish in the first two (2) places.

## **2.4. MATCHES OF CYPRUS TEAMS**

In the case of football bets, betting on the results of matches with Cypriot Teams either on the territory of Cyprus or abroad is only allowed when it is made in combination with the results of matches of at least three other foreign teams. The same applies to betting on the results of matches held with the Cyprus National Team.

## **2.5. SPECIAL ' LIVEBETTING ' REGULATIONS**

The Market " Live Betting " will be offered before and during an event exclusively from the platform " Live Betting ". The "Odds" will be constantly updated to reflect the image of each event. To avoid the non-acceptance of a "Bet" due to the change of one or more "Odds", the "Client" can accept the option "Accept all Odds changes" or "accept higher or lower Odds" when placing a "Bet". It is noted that the validation of the bet ticket is done at the work counter by the authorized representative or the responsible person. Where applicable, the statistics provided to us by the provider of the " Live Betting ", will be used to settle 'Bets'. In the event that coverage of an event by the service provider stops or is interrupted due to a technical problem and causes the incorrect display of " Odds " and/or therefore the markets remain open while the various events such as goals, yellow cards, red cards, penalties have occurs, resulting in the incorrect calculation of profits, then the provider will cancel all " Bets " placed during the period of time that the above problem exists. Therefore, the " Company " , due to its contractual obligations with the service provider, reserves the right to cancel such " Bets " . Where no service provider statistics are given, video evidence will be used to support the correct way of settling the 'Bet'. If for any reason, there is no video proof, independent proof will be used and the 'Bet' will be settled based on the official websites of the respective events/official sources.

The "Company", due to its contractual obligations with the service provider, will apply the following:

If the result of a purchase cannot be determined from official sources, the "Company" reserves the right to delay payment until the announcement of the official results.

If a market is offered and the outcome of the event is known, then the "Company" reserves the right to cancel "Bets" on that market.

In the event that there is an obvious error in the "Odds", the "Company" reserves the right to cancel "Bets", including a deviation of more than 100% in the profit of any coupon compared to the average of the rest of the market.

In the event that the broadcast of an event is interrupted due to technical problems and the match is completed normally, then all markets for that match will be settled based on the final result.

In case of incorrect arrangement of a purchase, the "Company" reserves the right to correct it.

In case where the basic regulations of a sport are violated, the "Company" reserves the right to cancel the purchase (eg variation in the duration of an event, in the regulations of an event, etc.).

In the event of non-completion or non-performance of an event (eg due to disqualification, interruption, withdrawal, change in draw) it will be deemed void, unless the bet is settled.

All markets (except half time, extra time and penalty shootout), will be calculated based on the regular duration of the event.

In the event that an event is interrupted during its duration and resumed from the point of interruption within 48 hours of its commencement, all open "Bets" relating to the specific event will be settled based on the final result. Otherwise, all open "Bets" will be considered void. If an event does not continue from where it left off but starts from the beginning, then all Bets will be settled as void .

A yellow card counts as 1 card and a red or yellow-red as 2. The second yellow on a player leading to red does not count. As a result a player cannot record more than 3 cards.

Settlement will be made on the basis of all available evidence for cards dealt during the normal course of a match.

Cards given after the end of the match are not counted.

Cards to non-competitors (players who have already been substituted, coaching staff, players on the bench who have not been substituted), do not count.

If the market remains open while the various events have already occurred: goal, yellow or yellow-red card, penalty, then the "Company" reserves the right to cancel these "Bets".

If any market is opened with an incorrect red card or by omitting one, then the Company reserves the right to void the Bets.

If the "Odds" offered are for a match with an incorrect start time (beyond 5 minutes), then the "Company" reserves the right to cancel the "Bets".

If a wrong result is entered, then all purchases will be canceled from the moment of the wrong entry.

If the team names or category are misrepresented then the Company reserves the right to void Bets.

A yellow card counts as 10 points and a red or yellow-red as 25. A second yellow card on a player leading to red does not count. As a result a player cannot score more than 35 points.

Settlement will be made on the basis of all available evidence for cards dealt during the normal course of a match.

Corners awarded but not taken will not count.

Own goals will not count towards the First / Next / Anytime Goalscorer purchase and will be ignored.

Football players who compete from the start of the match or from the moment of reaching the previous goal are considered as runners.

All football players participating in a match are offered for betting. In the event that a footballer scores a goal and is not listed, then all "Bets" on footballers who are on the list stand as normal.

The purchase will be settled based on of the official websites of the respective events/official sources.

In the event that an event is not completed within 48 hours of its official start, then all 'Bets' for that event will be deemed void, except for those already settled.

Any complaint regarding any result should be submitted in writing to the head office of the "Company" within 7 days of the event.

Clarification Bets :

Winner of rest of match

Which team will win the remainder of the match (regular duration) from the moment the "Bet" is placed. Only goals scored after the "Bet" has been confirmed will count (the current score will be printed on the "Bet Slip"). An own goal will count for the opposing team and not for the team that scored it.

Some events are scheduled to last less than usual. Under such circumstances the "Bets" will be settled based on the specifics of each case. B.C. some youth football matches last 80 minutes instead of 90 minutes, so 'Bets' relating to those matches will be settled based on the final result of the 80 minutes.

Cancellation or refunds for LIVE Bets will not be accepted for any reason BETTING . If a 'Bet' LIVE BET is entered with an incorrect 'Odd' due to a delayed rebroadcast of the event, then the 'Bet' will be considered VOID at odds of 1.00(one unit), regardless of whether the 'Bet' wins or loses.

## **2.6. Safe Game.**

"Betting" is for adult entertainment and is not a way to make money. Don't push your luck. Bet only what you can afford to lose. If you think you have a gambling addiction problem, consult the mental health services of the Ministry of Health on number 1454 and the "Perseus" Counseling Center on number 1456 if you are an adult up to 22 years old.

## **2.7. PROCEDURES TO PREVENT AND FIGHT LAUNDERING OF INCOME FROM ILLEGAL ACTIVITIES**

The "Company" and its intermediaries use anti-money laundering procedures and suspicious transactions will be reported to the relevant authorities.

## **2.8. MINIMUM BET AMOUNT**

The minimum bet amount is €1 per 'Bet Slip' , and 3 cents (0.03c) per line.
