TERMS AND CONDITIONS OF CLASS A COMPANY'S BET ON ALFA (Betonalfa Ltd - Licence No A005)

These Regulations are in force from 31/01/2025 (Version 1)

- 1) General rules.
- 1.1) These Terms and Conditions apply to wagering that takes place on the licensed premises of Betonalfa. It is understood that the validity also covers the premises of the company's authorised representatives.
- 1.2) The word "Betonalfa" in this text refers to the company Bet On Alfa Ltd (HE237951) with an address at 70 John Kennedy Avenue, First Floor, Postcode 1076, Nicosia. Betonalfa is a licensed company and is subject to the rules of the Cyprus National Betting Authority. The company's License number is A005. The National Betting Authority is the public regulatory authority responsible for the administration of sports betting in Cyprus.
- 1.3) These Terms and Conditions constitute the entire terms and conditions by which you participate in a bet as conducted by Betonalfa and for which you confirm that you are fully informed.
- 1.4) These Terms and Conditions will come into force as soon as they are approved by the National Betting Authority. You will be notified of their entry into force by their posting within the Company's premises. If you do not agree to any part of these Terms and Conditions, you must not place a bet at a company's premises.
- 1.5) You fully understand and agree to be bound by the Terms and Conditions set forth herein and understand that they may be amended from time to time. It is understood that any amendment will be subject to prior approval by the National Betting Authority of Cyprus.
- 1.6) Any amendment will be posted (immediately after its approval) at the company's premises.
 It is your sole responsibility to check the new contract/terms with the specific rules of each product/offer you choose to participate in.
- 1.7) Betonalfa strives to provide excellent customer service. As part of this pursuit, Betonalfa supports safe gaming. For more information you can visit the relevant links available on our website www.betonalfa.com. Although Betonalfa will use its best endeavours to reinforce its safe gambling policies, it does not accept any responsibility or liability if you nevertheless continue to bet and/or use its services, if such use is beyond its reasonable control.

- 1.8) The Terms and Conditions may be published in various languages for information purposes and player convenience. In the event of a different wording of the Greek version to any other language version, whether mandatory to exist/Turkish or potential one, then the Greek version shall prevail.
- 1.9) Betonalfa maintains a strict policy regarding the confidentiality of the information it collects regarding each of its customers, in compliance with the applicable legislation. For the company's privacy policy you can visit the link www.betonalfa.com.cy/site/privacy.
- 1.10) These terms and conditions are governed by Cyprus Law and are subject to the jurisdiction of the courts of Cyprus.
- 2. Betting on Betonalfa
- 2.1) All customers must be over 18 years of age to be able to place bets at Betonalfa. Betonalfa reserves the right to request proof of age from any of its customers to verify their age. If for any reason any customer under the age of 18 is found to have placed a betslip, the betslip will automatically be cancelled, their funds will be frozen and the National Betting Authority will be informed immediately. Any person who invites, incites or permits an underage person to engage in betting or to enter a licensed premises, is guilty of a criminal offence.
- 2.2) Betonalfa reserves the right to refuse to accept bets from any customer it wishes.
- 2.3) Betonalfa will carry out additional identification procedures for any betslip or betslips that cumulatively exceed the equivalent of €2,000 or in the case of a business relationship (player registration), as an obligation arising from both the National Betting Authority's instructions and the applicable legislation and reserves the right to carry out such identification procedures in cases of smaller amounts. All transactions will be checked to prevent illegal activities (money laundering). For purposes of player identification, Betonalfa is required to collect, at a minimum:
 - (a) the full name of the player,
 - (b) the date and place of birth,
 - (c) nationality,
 - (d) permanent address; and
 - (e) contact details (telephone and/or e-mail)

Betonalfa will collect, for the purposes of compliance with the above, at least the player's identity card or passport. If not satisfied with these documents, it may request the player to provide additional documentation to confirm his/her details and verify his/her permanent address. For

these purposes, a utility bill may be provided. A utility bill issued by the following organisations shall be accepted as a utility bill:

- (a) by a telecommunications organisation only for internet, pay-TV or landline services and does not include a bill for mobile services,
- (b) by the Electricity Authority of Cyprus (EAC),
- (c) by Water Supply and Sewerage Boards,
- (d) by local government authorities only for waste collection tax, property tax or other tax bills.
- 2.4) As part of the company's compliance with the Prevention and Combating of Money Laundering Act of 2007 (188)(I)/2007), we may carry out a further check whether you are e.g. a politically exposed person, a person on a sanctions list, etc.
- 3. Your BETONALFA Transactions.
- 3.1) Betonalfa has the right to appoint Payment Providers to act and/or receive funds on behalf of Betonalfa. Payments may be made by cash, bank cheque, debit/credit cards.
- 3.2) Betonalfa does not charge for payments made by Debit/Credit Card. However, please be aware that some card issuers consider betting transactions as cash payments and for this reason you may be charged a cash advance fee. We recommend that you contact your card issuer for further details.
- 3.3) We only accept payments in EUR (EURO). Any payment received by Betonalfa in another currency will be converted into EUR at the current exchange rate. Please note that any exchange premiums are at your expense.
- 3.4) In order to be able to participate in bets, you must pay your betslip before placing your bet, as Betonalfa does not accept bets on credit in compliance with Article 27 of the Betting Law of 2019 (37(I)/2019).
- 3.5) Card payments (debit, credit, etc.) may at times be partially and/or fully rejected as being subject to security systems operated in cooperation with payment system providers and/or financial institutions. These security systems may reject transactions with cards that are valid, but at the time the transaction cannot be completed. Betonalfa personnel do not exercise control over these systems, nor can they know in most cases the reason why each transaction is rejected.
- 3.6) Winnings payments to players are made either via cash, or via bank transfer/bank cheque. In the event of a payment exceeding €2,000.00, for due diligence purposes, the player will be asked to provide the details set out in paragraph 2.3 of these terms and conditions. In any case where the winning payment exceeds €10,000.00 the payment shall be made exclusively by bank transfer or bank cheque.

- 4. Your Obligations
- 4.1) You represent and warrant the following:
- 4.2) You are over 18 years old. Also that you are entitled under the jurisdictional laws applicable to you to participate in the betting offered by the company.
- 4.3) You use our services strictly in your personal and non-professional capacity for entertainment and fun purposes only.
- 4.4) You are using our services on your own behalf and not on behalf of any other person.
- 4.5) The responsibility for reporting or not to the tax authorities rests solely with you.
- 4.6) All the money you deposit with Betonlalfa is not tainted with any illegality and especially not from any illegal activity or source.
- 4.7) You understand that by using our services you take the risk of losing money you have bet on the licensed Betonalfa premises.
- 4.8) You will not engage in any fraud or collusion relating to your participation or the participation of others in any bet and will not use any method or technique using software or hardware (Technical Equipment) to participate in any bet. For this reason, Betonalfa reserves the right to cancel your participation in any bets if you engage in the conduct described above.
- 4.9) You are not listed as an addicted problem gambler, and/or are not included (either voluntarily or involuntarily) in any registry or database of disqualified customers.

5. Bet

- 5.1) For betting rules see the posted regulations. Please note that the betting rules are the set of rules by which you participate in betting as conducted by Betonalfa. By accepting the Terms and Conditions of the company, you confirm that you have read the Betting Rules, understand them and agree to act in accordance with them.
- 5.2) Betonalfa reserves the right to refuse all or part of any bet/prize requested without providing any justification. All bets/premiums are placed at your own risk and discretion.
- 5.3) A bet/betting request will only be valid when you receive the betslip printed from the company's computerized system, which carries a unique transaction code. We will not be responsible for settling any bets/premiums which are not issued with a unique transaction code. If you are unsure of the validity of a bet/premium, please check your betslip or contact us.
- 5.4) After the final outcome, each bet is governed by the version of the Terms and Conditions/Regulations in force at the time the bet is accepted.
- 5.5) The customer confirms that at the time he placed one or more bets he had absolutely no knowledge of the outcome of the respective events. Bets are prohibited on events in which the customer is either directly involved or has access to confidential information . If there is a

suspected violation of this rule, the company reserves the right to cancel the bet and refuse to pay the winnings. It also reserves the right to take further action to protect its legitimate interests and to comply with other applicable Laws and Regulations, including taking legal action to recover any amounts paid.

- 5.6) The minimum stake per betslip is €1.
- 5.7) The list of all bets, the status, as well as their details are available to the customer via our Website https://shop.betonalfasports.com/b/xxxxxxxxxxxx (where xxxxxxxxxxxxxxx is the unique betslip number) by scanning the QR code of your betslip from your mobile phone.
- 5.8) The company reserves the right to declare all bets on an event, or some events, as void if they originate from a group of customers who appear to have had knowledge of their outcome and/or acted together in order to exploit this knowledge and/or bet together so as to exceed the company's betting limits in terms of maximum payout per event or betslip e.g. betting spiral, criminal syndicate/organization. In the event of a bet being cancelled, relevant documentation will be provided to the player. Betonalfa also reserves the right to report to the National Betting Authority and the Anti-Cover-Up Offences Unit froemd(ACU) if a user is involved in any form of suspicious and fraudulent behaviour.
- 5.9) When a bet is declared void it will be settled at odds of 1.00. The user will be paid the amount he/she had placed on that bet. In case of parlay (combination) bets, the void result will not be included in the calculation of (total) odds.
- 5.10) Except for Live betting, any bet placed after the start of the event is void and will be settled at odds of 1.00.
- 5.11) Any bet that has been placed and accepted cannot be modified, withdrawn or cancelled unless requested by the customer/player and expressly approved by the company. It is understood that in the case of bets for which manipulation is suspected and which are settled as won: 1. the payment of winnings will be suspended until the investigation of the case is completed and the player will be informed accordingly; 2. Betonalfa will inform the competent authorities; 3. upon completion of the investigation of the case Betonalfa will inform the player of the outcome of his/her bet. Betonalfa also reserves the right to report to the National Betting Authority and the Anti-Cover-Up Offences Unit if a customer is involved in any form of suspicious and fraudulent behaviour.

- 5.12) Each time the customer places a bet(s), he/she automatically acknowledges that he/she has read, understood and fully accepted all the terms and conditions of the offered market regarding bets offered by Betonalfa on the specific market as described in its betting regulations.
- 5.13) Customers are solely responsible for the bets they place. Betonalfa is not responsible for possible errors that may occur when placing bets, including errors regarding the amounts wagered.
- 5.14) Winnings from bets with fixed odds are calculated by multiplying the amount wagered by the fixed odds.
- 5.15) Any modification of the result later after the completion of the event or the event (if it is a bet on the event), e.g. disciplinary proceedings (e.g. doping), or interference by regulatory bodies, have no effect on the result.
- 5.16) Predictions for matches that are not held or postponed for any reason will remain valid for 48 hours. If at the end of 48 hours the match is not held, they will be considered void on the Betting Form, unless otherwise specified in the specific rules of the sport. The above predictions for the purpose of calculating winnings shall be considered at odds of 1.00 (unit).
- 5.17) Maximum Limits: The maximum limits per betslip for each sport and bet type are detailed below. Where multiple bets are placed involving events with different maximum win limits then the lower limit will apply.

- 5.18) The maximum weekly win (7 calendar days) on football events (soccer) is two hundred and fifty thousand euros (€250,000), regardless of the value of the bet or odds. The maximum weekly win (7 calendar days) on other sports is one hundred thousand euros (€100,000), regardless of the value of the bet or odds.
- 5.19) Where a multiple bet has been placed involving events with different maximum win limits then the lower limit will apply. All maximum win limits apply to each individual customer, or group of customers acting together, or to bets that are reasonably suspected to belong to the same customer or group of customers, containing bets with the same selections or substantially the same selections, including series of bets in different price ranges, and/or different days and/or submissions at different premises. If we have any reason to believe that a number of bets have been placed in this way the total payout for all bets that have been combined will be limited to a single maximum payout of winnings.
- 5.20) If it comes to Betonalfa's attention that a customer has placed a number of bets from different premises and/or the same premises, on the same and/or different days and times, Betonalfa reserves the right to cancel all bets placed through them. The stakes on the respective bets will be refunded to the customer, but not the potential winnings.
- 5.21) In the event that suspicious betting activity is observed, Betonalfa reserves the right of further investigation in cooperation with the National Betting Authority, the Anti-Cover-Up Offences Unit (ACU), any competent authority including any Federations or Organising Authorities. Until the process is completed, bets will remain open. It is understood that if suspicious betting activity is observed prior to the start of the match, Betonalfa reserves the right to settle the match at odds of 1.00, informing the National Betting Authority accordingly.

7. Limitation of Liability

7.1) You enter our licensed premises and participate in betting at your own risk. The terminals and products are provided without any warranty, express or implied. In particular, Betonalfa, its management, employees, partners and service providers a) do not warrant that the software or the Website are fit for purpose, b) do not warrant that the software and the Website are free

- from errors, c) do not warrant that the Website and our products will always be accessible without interruption and will not be liable for any losses, costs, expenses or damages.
- 7.2) Wherever Betonalfa provides recommendations for betting activity, these will be based on statistics that we have received from third parties (e.g. Opta stats or sportsradar) and we cannot guarantee their accuracy. These recommendations will be indicative and in no case will they be considered as advice/recommendations and/or guarantee any profit.
- 7.3) You hereby agree to indemnify and hold non-responsible Betonalfa, its management, employees, associates and service providers for any cost, expense, loss, damage, claim, liability or anything else that may arise from the use of its services at its licensed premises and your participation in the betting.
- 7.4) Any information given by the customer service department is purely for the purpose of customer guidance. Although we endeavour to ensure that all information provided to customers is accurate and correct, ultimately it is the responsibility of customers to ensure that they understand the nature of the bets they are placing, as well as the terms and regulations.
- 8. Reporting procedure against money laundering
- 8.1) Betonalfa fully complies with the anti-money laundering legislation as well as the instructions of the National Betting Authority. Betonalfa will report any suspicious transaction to the competent authorities of the Republic of Cyprus.
- 8.2) Betonalfa has the right to suspend or block your bet (betslip) and withhold funds if requested to do so in order to comply with the relevant anti-money laundering laws.
- 8.3) Betonalfa has some specific requirements from you arising from the obligation to comply with the reporting procedures for "Money Laundering". You guarantee that the name and address you provide in case of identification are correct and that you are the legal owner of the money you have wagered at any time.
- 9. Infringements, penalties and termination
- 9.1) In case Betonalfa suspects that you are involved in fraudulent or illegal activities during your stay at our premises the company will cancel your betting betslips by giving you the relevant justification.

- 9.2) Betonalfa reserves the right, at any time (even after a bet has been settled), to (i) refuse any bet or part thereof, (ii) cancel any bet or part thereof, if it finds that there is collusion between customers. In such a case, outstanding bets that are not subject to refusal or cancellation will be paid. In addition, Betonalfa also reserves the right to take legal action against customers in the event that the National Betting Authority finds that collusion has been committed. It is noted that Betonalfa will inform the National Betting Authority on a monthly basis about the aforementioned.
- 9.3) Betonalfa reserves the right to cancel all bets placed by any group of people acting in collaboration. This may include individuals, relatives, organisations, companies offering bets and their employees. It is understood that Betonalfa will inform the competent authorities of the Republic of Cyprus in such a case.
- 9.4) The redemption time for winning betslips is two (2) months from the day it was settled as a winning bet. To collect the betslip the customer must present the winning betslip at the branch. In case of loss of the betslip, you must submit a sworn statement describing the betslip and the company reserves the right to pay for it if it deems that you are indeed the beneficiary of the betslip. In particular, a customer claiming a lost betslip will fill in details of this bet on a form which will include the betting options, the premises where the bet was placed and (approximately) the time the bet was placed. In the event that the two (2) month period has elapsed, the winnings from the betslip cannot be claimed and will remain with the company.
- 9.5) You acknowledge that Betonalfa will be the judge of whether you have violated its rules, Terms and Conditions in a manner that will lead Betonalfa to suspend or permanently block your participation in our premises. It is understood that in the event of complaints, the final arbiter is the National Betting Authority.
- 10. Languages. Our rules are displayed in the official languages, Greek and Turkish. It is understood that additional languages e.g. English will be offered where possible.

11. Intellectual Property

- 11.1) Any unauthorized use of Betonalfa trademarks and logos may result in your prosecution.
- 11.2) Betonalfa is the owner of the legal license for the rights to the technology, software and business systems used in its premises.

- 11.3) Links to the Website and to any of its sub-pages are prohibited to be included in any other Website without the prior written consent of Betonalfa.
- 11.4) You agree not to use automatic or manual devices to monitor Betonalfa's websites and content. Any unauthorized use or reproduction may result in criminal prosecution.
- 12. **Severability** In the event that any provision of these Terms and Conditions is held to be unlawful or unenforceable, then that provision will be severed from these Terms and Conditions and all other provisions will remain in force and unaffected by such severance.
- 13. These Terms and Conditions constitute the entire terms by which you participate in a bet in relation to the company's premises and, except in the case of fraud, they replace all previous or current communications or proposals, whether electronic, oral or written between you and Betonalfa. The printed version of the Terms and Conditions and any notice/notice in electronic form shall be admissible in judicial or administrative proceedings based on or relating to them and indeed to the same extent and under the same conditions as other business documents and records created and maintained in printed form.
